

# Santa Cruz Beach Boardwalk Band Field Trip

**WHAT/WHERE?** On Saturday, May 11th 2019, the Faria intermediate band will perform in a band competition, and spend the day at, the Santa Cruz Beach Boardwalk! At the end of the day, students will attend an awards ceremony where their band will be presented with a trophy for their performance. This festival is put on by “Music in the Parks”, which has been in operation since 1980 and conducts these events in over 30 cities throughout America and Canada.

**WHEN?** The Competition will take place from 1:45-2:45pm. Students may sign up for just the competition portion if they wish.

**Due to insurance reasons, each child’s parent will need to transport and supervise their child throughout this entire event.**

**PRICES** There is a cost for this event but the company offers some nice discounts. There are two parts to the cost of this event: 1) The Competition (\$35) and 2) One Day Park Admission (\$35). One-day park admission allows participants to ride unlimited attractions. NOTE: Parents do not need to purchase admission to the park if they don’t wish to ride any attractions.

Parents that take students to the Boardwalk will be responsible for any parking fees. Prices are below.
